For annual Services Maintains Contract of Model CT scan (Canon, Toshiba) Aquilion-64 Slice for Financial Year 2024-25

- 1. The contract will be for the period of one year for the financial year 2024-25 from the date of issuance of contract, further extendable for further 01 year if agreed by both parties on the satisfactory report by the end user and Bio Medical Engineer/DMS-M&R. OR the price shall be fixed and valid till 30th June 2025 & may be extended for a period of three months or till the finalization of new tender with mutual consensus.
- 2. Sealed bids are invited from the reputed firms, with established credential in terms of technical, financial, and managerial capabilities and registered with income & sale tax departments for the Annual Service and Maintenance contract of CT scan (Canon, Toshiba) Aquilion-64 Slice with all parts without X-Ray Tube and consumable.
- 3. The firm will be bound for the Service & Maintenance with all parts without X-Ray Tube and consumable of the mentioned equipment during the contract period.
- 4. The sealed bids are required to be brought in person by the authorized representative of the interested bidders on the proposed dates and to be dropped in the tender box by the closing time. The late arrivals and bids sent by post will not be entertained. The tenders will be opened by the purchase committee in the presence of the bidders or their authorized bidders (who choose to be present) in the Committee Room of Saidu Group of Teaching Hospital, Swat.
- 5. Offer of the firm not quoting rates both in words/figures shall not be considered for competition.

- 8. **Technical Evaluation Criteria**

 - The firm must provide a Valid Authorization letter and spare parts availability certificate from the original manufacturer.
 - Infrastructure for execution of after sales services mentioned by the bidder shall be evaluated for its suitability as per provisions given in specification of other requirements mentioned in the bidding documents.

11. In case of any dispute and violation of aforementioned clauses of the agreement, the decision of the Institution will be final.
 12. The firm will be bound to replace the brand-new parts after proper entry into the stock register of the store and duly checked & verified by the Authority and Bio Medical Engineer/DMS-M&R/End-User of this hospital prior to be replaced/ installed in the relevant equipment.
 13. The envelopes must be properly sealed.
 14. In case the offer is withdrawn, amended, or revised during the validity period of the offer, the earnest money is liable to be forfeited.
 15. The Medical Superintendent, Saidu Group of Teaching Hospital, Swat reserves the right to claim compensation for the loss caused by the delay or damage during repair process.

 17. Any conditional, ambiguous, or incomplete offer in any respect shall be ignored. No supplementary or revised offer after the opening the tenders shall be entertained.
 18. Tenderers should indicate in their tenders the complete address of office as well as workshop.
 19. Any erasing/cutting/crossing etc. appearing in the offer must be properly signed and stumped by the person signing the tender. Moreover, all pages of the tender must also be properly signed, offers with any over- writing shall in no circumstances be accepted.
 20. The firm quoting the rates must be registered with the Income Tax Department and Sales Tax Department.
 21. All rates must be quoted including Sales Tax.
 22. The firm / bidder quotes the rate with parts (if any).
 23. Any offer not fulfilling any terms and condition shall be straight way rejected.
 24. Offer of the firm not quoting rate both in words / figures shall be rejected.
 25. The firm must have past performance in the relevant field. The certificate must be attached to this effect.
 26. **NO OFFER SHALL BE CONSIDERED IF:**
 - i. It is received after the time and date fixed for its receipt
 - ii. The tender is unsigned.
 - iii. The offer is ambiguous.
 - iv. The offer is conditional.
 - v. The offer submitted JVA.
 - vi. The offer is from a firm black listed by any Govt. authority.

 - xii. The service record of each CT scan TOSHIBA AQUILION 64 Slice including details of parts replaced or any additional information that the authority may require shall be maintained at the end of concerned firm and end user/ bio medical engineering.
 - xiii. The firm will base a permanent technical person whole time in KPK.
 27. The firms shall be bound to hand over the part or parts replaced, to the concerned department under proper report and detail of entry of such parts in breakage book.
 28. The firm shall be bound to keep up time of CT scan TOSHIBA AQUILION 64 Slice of (95%) uptime during the period of contract. It will be the responsibility of the firm failing which the down time calculated by the Radiology Department and firm on the log book duly verified by Bio- Medical Engineer/DMS-M&R/End-User of Saidu Group of Teaching Hospital, Swat. The down time will not be paid.
 29. The following formula will be applied for down time calculation.
 - I. 100-95% No penalty.

- II. 95-85% the service contract will be extended by 2 times the number of days as extra down time.
 - III. 85-75% the service contract will be extended by 3 times the number of days as extra down time.
 - IV. 75% or below the service contract will be extended by 4 times the number of days as extra down time.
 - V. Planned preventive maintenance (PPM) will not be considered as downtime.
 - VI. The firm shall be bound to keep the system fully functional during office hours defined as the hours of 03:00 AM to 05:00 PM Monday to Friday except gazette Holidays. The down time calculation will be on the basis of 365 days a year.
30. Performance of the firm and bills of firm will be cleared on the satisfactory report of the firm duly satisfied by Head of Radiology Deptt and Bio-Medical Engineer of Saidu Group of Teaching Hospital, Swat of every quarter of the contract.
 31. Quoting firm would not be allowed to withdraw his offer during the contract period.
 32. The decision of the committee / authority will be considered as final and would be decided as per law.
 33. Tender form should be signed for acceptance of terms and conditions by the tenderer and submit along with quotation.
 34. Tender must be submitted under sealed cover.
 35. Firms should indicate in their tenders, the complete address of the office and workshop with telephone No. and cell No.
 36. The tenderers must have their own workshop physically and can be checked at any time by the committee / authority. In case of bogus information and if the workshop does not exist physically, then the tender will be cancelled. CDR and security will be forfeited and the firm will be blacklisted.
 37. The contract is subject to the agreement in writing on judicial paper worth Rs. 1200/- . It should be made within 07 days after the finalization of contract. In case of failure the contract will be cancelled and call deposit/security will be forfeited.
 38. The firm shall pay the income tax chargeable @ prescribed by the Government (if any) and all other taxes levied during their contract period, will also be paid by the firm.
 39. The firm will abide by any condition, rules and regulations issued from the Govt. of the Punjab or any competent authority during the period of contract.
 40. The firm shall be bound to complete the repair, service and maintenance work of CT scan TOSHIBA AQUILION 64 Slice inside the hospital premises. If any part is needed to take outside hospital premises for repair work it should be done only with prior permission from the authority.
 41. In the light of section 22(a) of schedule-I of Stamp Duty Act 1899 read with Finance Act 1995 (Act VI of 1995), the firm will pay stamp duty on the amount of the contract.
 42. Call deposit / security will be released after the expiry of contract period and satisfactory report from the end user / bio medical engineer.
 43. In case of violation of any terms and conditions of the contract / agreement the call deposit / security will be forfeited, and the firm will be blacklisted.
 44. In case of any dispute and violation of the aforesaid clause of the agreement the decision of the Medical Superintendent Saidu Group of Teaching Hospital, Swat will be final and will not be challenged in any court of Law.
 45. The firm will be bound to repair, service and maintenance of the CT scan TOSHIBA AQUILION 64 Slice from the fully qualified/trained engineers.
 46. The bidder should have at least Five (05) foreign trained engineers on CT-Scanner, documentary proof should have to be provided in this regard.
 47. Quoting firm is required to provide certificate from manufacturer that firm will provide Field Modification Instruction (FMI) / Software up-gradation as and when required / advised by the original manufacturer. There should be confirmation from Factory.

- 48. The firm will be bound to make the CT scan TOSHIBA AQUILION 64 Slice fully functional according to the satisfaction of the Head of Radiology Department, failing which payment will not be made.
- 49. The firm will be responsible to rectify any loss occurred during its repair /service, at its own cost and expenses.
- 50. The firm will directly be responsible for maintaining and full functioning of the CT scan TOSHIBA AQUILION 64 Slice, in case of replacement of any part / parts, the firm is bound to inform Bio-Medical department & Radiology Department and will also include it in Logbook held by Department.
- 51. The response time of the firm for any complaint or any non-functionality of the machine in whatever condition is 24 hours.
- 52. Firm must have tools, calibration equipment regarding repair and calibration of C.T Scan and a certificate must be provided regarding list of calibration tools.
- 53. The services agreement is payable in 04 equal installments per year.
- 54. The company should have proper workshop with required test tools for calibration for the system which can be verified by the hospital if required.
- 55. Manufacture confirmation that factory technical support will be available in case of a major fault.
