2. Proceedings of the Meeting

The meeting commenced at **10:00 AM** with recitation from the **Holy Quran**.

The Chairman welcomed the participants and briefed the Committee that the grievances relating to Surgical Disposable Items would be examined **item-wise**, strictly in accordance with the **Bidding Solicitation Document (BSD)** and **KPPRA Rules**, ensuring transparency, fairness, and merit.

3. Grievances Related to Surgical Disposable Items

The grievances, along with detailed observations and decisions of the Committee, are summarized below:

Case No. 01

Firm: M/s Jawad Traders

Items Involved: BSD Item Nos. **13, 14, 16, 17 & 26**

(Sample Demonstration Proforma attached as Annex-I)

Statement of Grievance:

The bidder contended that being the lowest and successful bidder for the aforementioned items, their samples were rejected after initial demonstration and the items were awarded to the next bidder at higher rates, allegedly causing financial loss to the hospital and violation of KPPRA Rules.

Committee Observations:

The Committee examined the grievance in light of **BSD Eligibility Criteria (Sr. No. 8)**, which stipulates that selection shall be based on satisfactory sample demonstration.






