## 2. SECTION-2: TERMS & CONDITIONS

1. Any bidding firm submitting any false/bogus/fake/forged document and/or previously involved in submitting any false/bogus/fake/forged document shall be disqualified, as well as shall be dealt with as per law.
2. These TORs shall be read along with the TORs given in the advertisement, where applicable, which by no means be in derogation of each other.
3. The firm shall submit their original price list per unit quantity per item/test along with the maximum discount in percentage (%) in total, on their original letter pad (complete address, reference #, or any other requirement), duly signed and stamped every page by the authorized person.
4. The dealing currency will be Pakistani Rupees. Conditional bidding will be rejected.
5. The rates shall be computer typed and printed. Handwritten rates or mutilated or cut or modified by hand will be considered rejected.
6. Bidders having minimum one (01) year of relevant experience Government/ Private Teaching Hospitals of the provision of services. Experience certificate of good services provision shall be attached.
7. The bidders are requested to give their highest possible discount on standard market rates for diagnostics, no negotiations on quoted rates are allowed under the KPPRA rules 2014.
8. The firm's facility shall be in the nearest possible vicinity to the hospital i.e., The Saidu Wing, and the Central Wing, SGTH Or within a range of 500 meters radius of/to the hospital, or at least there should be collection point at the other wing, if the facility is near to one of the above wings.
9. The facility shall remain open 24/7/365 for the provision of services.
10. The firm should be a well-reputed and Category-A registered facility, for which the copy of Cat-A shall be attached duly attested from the concerned department and shall be attached with the bid.
11. The firm shall provide names, attested copies (legible/visible) of CNICs, two recent attested photographs, valid street addresses, all working landline and mobile phone numbers of the following:

All histopathological biopsies needing specialized markers/immunohistochemical stains shall be sent to the successful bidder/contractor which will further be decided by the contractor to forward the same to other well refuted national laboratories for up-to the mark results, and to meet the criteria of single point services to the ailing public.
