4. Bids shall be delivered at the address given below before 10:30 am 15-01-2024. 5. Any bids received late shall be rejected as per KPPRA rules (37-4). 6. All the firm's shall be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) where applicable. 7. Tender/bid will be opened by Purchase Committee SGTH Swat, in front of Firm / bidders in the conference room MS Office. 8. The firm must be on FBR Active Tax payer list. 9. The taxes will be deducted as per rules. 10. The firms must provide detail of NTN #, Sales Tax #, Income Tax # and professional Tax # & all other Taxes. 11. No conditional tender will be acceptable.
